OTHER SIGNIFICANT ACCOMPLISHMENTS

Improved Land Administration and Management

For socio-economic and environmental development sound land administration and sustainable management are important and crucial for good governance. Highlighting the Region's activities on land disposition was the issuance of patents which creates a sense of security to qualified beneficiaries. Land cases and complaints were addressed thru amicable settlement and Alternative Dispute Resolution (ADR).

Patent Issuance

After a long wait, finally the smiles beamed in the faces of the recipients holding the title of the land they tilled for the longest time. For CY 2023, the Region issued a total of 2,285 patents of which 944 residential (118%), 1,248 agricultural (156%), and 81 special patents (418%). Under residential free patent, among the six (6) provinces Aklan had the highest target of 200 and accomplished 258 (129%) and the same is true in agricultural free patent with 200 targets and 508 (254%) accomplishment. For the issuance of special patents, the province of Iloilo had the highest target of 25 and accomplished 30 (120%).

In terms of resolution of land cases, 46 ADR proceedings (329%) and one (1) amicable








Table 6. Residential Free Patent Issued CY 2023

Other Activities under Lands

As part of sound management of land administration, other activities accomplished: 1,066 (152%) lots surveyed and approved for residential and 1,222 (175%) for agricultural areas; processed 12 (109%) foreshore area applications for issuance of lease contracts; issuance of 30 (100%) revocable permits from CENROs Guimbal and Sara in the province of Iloilo; approval of 2,646 survey plans through Land Administration Management System (LAMS); and verification and correction of 11 datasets as part of Digital Cadastral Database (DCDB) Cleansing for survey records (Tubungan and Sara, Iloilo; President Roxas, Roxas City, Sapian, Sigma and Tapaz, Capiz; Buenavista, Jordan, Nueva Valencia and San Lorenzo, Guimaras).

For maintenance of land records, one (1) database has been maintained for regional LAMS (GAD mainstreamed); scanning and encoding of 2,559 new patents; and hiring of four (4) Geodetic Engineers.

To avoid overlapping of the Certificate of Ancestral Domain Title (CADT) or Certificate of Land Ancestral Land Title (CALT) of the National Commission of Indigenous People (NCIP) with the ENR projects, there (3) projections of CADTs/CALTs were conducted in the



municipalities of Calinog in Iloilo province and Tapaz and Dumarao in Capiz.

Community-Based Forest Management—Comprehensive Agrarian Report Program (CBFM-CARP)

The implementation of the program continually benefitted the qualified upland communities. The program has six (6) components: Support to Agroforestry and Livelihood Development; Enterprise Livelihood thru Financial Assistance/Subsidy to PO; GIS Mapping of completed CBFM-CARP Projects in CY 2007 and 2008; conduct of Multi-Stakeholders Regional Action and Communication Planning in support to the updated CBFM Strategic Plan (CY 2023-2032); Organizational Development Skills Enhancement; and hiring of Monitoring and Evaluation Officer.

For the year, only one (1) CBFM-PO was the recipient of support to agroforestry and livelihood development. The recipient PO is Dalicanan Agroforestry Farmers Association (DAFFA) located at Brgy. Dalicanan, Passi City. The area developed was 16 hectares where six (6) hectares planted with 2,400 mahogany and 10 hectares planted with 1,000 fruit trees. The agricultural crops planted were beans, squash and eggplants and the working animals procured were two (2) carabaos registered under the association.

The recipient of the livelihood enterprise thru financial assistance/subsidy of Php 1,470,000.00 was Inampuagan Highland Farmer Association, Inc. (IHFA) located in So. Inampuagan, Brgy. San Antonio, Barotac Viejo, Iloilo. The livelihood subsidized were coffee processing machine and packaging plant. The coffee plantation was established in CY 2010 and with the assistance received for CY 2023 they expressed their interest to expand their plantation. Also planted in the area were bananas.

To measure the impact of the projects after five (5) years from its implementation, two (2) socio-economic and environment baselining surveys (SEEB) were conducted to Inampuagan



Highland Farmers Association (IHFA) with 32 respondents; and Dalicanan Agro-Forestry Farmers Association (DAFFA) with 25 respondents. The data gathered will be the baseline in the conduct of the project's impact to the beneficiaries and environment.

Monitoring and evaluation were conducted in the 14 CBFM-CARP projects covering CYs 2009, 2010, 2012, 2016, 2019, 2020, 2021, and 2022.

Monitoring of different CBFM-CARP projects implemented

The conduct of reconnaissance and actual ground survey of CYs 2007 and 2008 CBFM-CARP Projects facilitated the completion of the GIS mapping of the said project. Based on the actual ground survey and GIS mapping a total of 316.94 hectares were re-surveyed/ accomplished with eight (8) generated maps, which exceeded the annual target of 313.0 hectares. For CY 2007, there are 100.39 hectares implemented by three (3) POs, namely: Patlabawon Integrated Social Forestry Upland Farmers Association, Inc. (PISFUFAI), Brgy. Patlabawon, Patnongon (31.39 has), Malalubi Upland Farmers Association (MUFAI), Brgys. Mablad, Langka-on, Lumboyan and Biga-a, Barbaza (32.37 has), and NISFFAI Development CooperativeBrgy. Nazuni, Dingle, Iloilo (36.63 has). For CY 2008, there are 216.55 hectares implemented by five (5) POs, namely: Tuno Upland Farmers Association (TUFA), Brgy. Tuno, Tibiao, Antique (35.0 has); Samahan ng Mambubukidsa Tabun-acan, Inc. (SMTPCI), Brgy. Pilar, Capiz (50.45 has); Southern Negros Forest Occupancy Permittees Association (SONFOPA), Brgys. Talacdan and Sura, Cauayan, Negros Occidental (85.78 has); Pangi Active Community Empowerment Development Association (PACEDA), Brgy. Pangi, San Dionisio, Iloilo (22.08 has); and United Canlusong for Upland Reforestation and Development (UCURD) (22.64 has).

POs. For 15 POs, a total of Php315,317.00 income was derived from the harvest of vegetables, bananas and other cash crops and bamboo crafts. The projects covered those implemented since 2010 until 2023.

003—Adaptive Capacities of Human Communities and Natural Systems Environment and Natural Resources Resiliency Program

The impact of climate change take its toll both to the people and environment, hence mitigating measures as well as adaptability and resiliency have been endeavoured. For Region 6, Environment and Natural Resources Resiliency Program was implemented with various activities undertaken such as preparation of watershed characterization cum vulnerability assessment in Dalanas River Watershed in the province of Antique; creation of Watershed Management Council (WMC); and validation/updating of watershed boundaries and naming of watershed based on ridge-to-reef validated boundary.

One (1) Watershed Characterization cum Vulnerability Assessment (WCVA) was conducted in Dalanas River Watershed, a medium watershed that covers a total area of 17,770.35 hectares. It is located in the province of Antique at the western portion of Panay Island and is bounded to the North by the municipality of Culasi, to the South by the municipalities of Laua-an and Bugasong, to the West by the Cuyo East Pass, and to the East by the province of Aklan and Capiz. Overall, the watershed covers an area spanning to a total of there (3) provinces, seven (7) municipalities, and 31 barangays.

One important initial component under the National Integrated Protected Areas System located within the watershed is the Dalanas River Watershed Forest Reserve (DRWFR) declared under Presidential Proclamation Number 603 of 1990. Said watershed has an area of 8,558 hectares and covers barangays of the municipality of Barbaza, namely: Marigne, Langca-on, Mayabay, Idao, and Nalusdan. The area is rich with diverse flora and fauna and has the presence of unique geological and hydrological formations which is also the reason for its inclusion as part of the proposed protected area under the Central Panay Mountain Range.

Hazards identified in the watershed were flooding and soil erosion. Using GIS, the potential impact maps of both these hazards were generated. Potential impact for flooding



showed that the watershed had a high (4,047.11 ha.) to moderate (3,839.12 ha.) susceptibility. On the other hand, the potential impact of soil erosion showed a very high (4,593.04 ha.) to high (4,804.46 ha.) susceptibility. Adaptive capacity of the barangays within the watershed were generated via house-to-house surveys and yielded an overall average rating of low for both hazards. Formulation of the vulnerability assessment maps used the potential impact and adaptive capacity for each hazard. Vulnerability assessment for flooding had a high (4,044.15 ha.) to moderate (5,506.48 ha.) result while for soil erosion it was from very high (8,267.17 ha.) to high (5,148.03 ha.) vulnerability.




Figure 4. Vulnerability Assessment Map of Dalanas River Watershed - Flooding

Based on the assessment conducted, there are three (3) main categories for mitigating measures that can be implemented in the watershed. These are green, engineering and community development measures. The policy recommendations include Forest Management Zoning for Dalanas River Watershed, issuance of appropriate tenurial instrument, and protection of remaining natural forests.






Figure 5. Vulnerability Assessment Map of Dalanas River Watershed - Erosion

The national and local government with the private sector and non-government organizations have been working in collaboration for the development of the watershed through rehabilitation and conservation efforts. However, the bio-physical condition of the watershed revealed by the result of the characterization and profiling that there is a need to conserve the resource and rehabilitate the degraded areas including those within alienable and disposable lands.

As regards the creation of Watershed Management Council (WMC), a Memorandum of Agreement (MOA) for the creation of Mau-It Tipulu-an River Integrated Watershed Management Council was conducted on August 23, 2023 at Diversion 21 Hotel, Iloilo City.

The council approved the resolution approving the Sibalom-Tipuluan River Watershed as the new name for the Mau-it Tipuluan River Integrated Watershed per DMC 2022-04. It was already submitted to the Central Office.

Ecosystem-Based Adaptation in Two (2) River Basins (E2RB) Project

Ilog-Hilabangan with an expansive basin area of 1,945 square kilometres ranked as the 11th largest river basin in the Philippines. The basin plays a pivotal role in the region's ecological balance and sustainability as it covers strategic cities and municipalities in Negros Occidental and Negros Oriental. Collaborative effort involving 15 local government units

(LGUs) of both provinces took center stage. Under Ecosystem-based Adaptation in 2 River basins (E2RB) Project, the LGUs actively engaged in implementing EbA strategies to address the pressing issues of flooding and landslide risks affecting vulnerable local communities. Consequently, local conservation areas (LCAs) was created. The targeted programs include reforestation and riverbank stabilization. The LGUs, including Candoni, Cauayan, Ilog, Himamaylan, Kabankalan, and Sipalay in in Negros Occidental, as well as Jimalalud, Ayungon, Tayasan, Manjuyod, Bindoy, Mabinay, Bayawan, Bais, and Tanjay in Negros Oriental, demonstrated their commitment by signing local subsidy agreements with the E2RB Project.




Figure 5. Ilog-Hilabangan River Basin Map



The activities include Basin Management Council Meeting, presentation on the proposal for local subsidy, and monitoring and progress assessment of LGU Sipalay City's local subsidy project.

The E2RB project covering the two (2) rivers situated in Ilog-Hilabangan River Basin is instrumental in address climate change concerns through conservation strategies in the area, hence mitigate issues on flooding and landslides.

Boracay Island Rehabilitation

Tagging Boracay Island as 'cesspool' in 2018 paved the way to the island's closure in April 2018 for rehabilitation. Different agencies and LGUs collaborated focusing on their mandate. Following the rehabilitation in June 2022, the offices successfully implemented policies outlined by Boracay Inter-Agency Task Force (BIATF), specifically on environmental protection, management and conservation. For CY 2023, CENRO Boracay started the year continually utilizing the remaining budget in 2022 until October 2023. Collaboration with Boracay stakeholders and other agencies sustained the continuance of the rehabilitation efforts which extensively begun in 2018.

The accomplishments include repair of four (4) vehicles and two (2) e-trikes; field visits; attended/conducted meetings/conferences; maintenance of buildings; release of scops owl in BalabagWetland Park, and female Olive Ridley in Ilig-Iligan Beach; intensification of forest revenue; hauling of apprehended/sized undocumented forest product; hiring of 12 Forest Protection Officers/Boracay LAWIN patrollers under regular fund and additional six (6) FPOS under downloaded fund; monitoring and patrol activities in Manocmanoc, Balabag and Yapak; conduct of investigation on ENR violations and complaints (rockfall incident of the famous "Keyhole" rock formation and discharging of wastewater within 25+5 m beach easement); and monitoring, rescue, rehabilitation, tagging and release of marine turtle habitat including CEPA activities.

Under the continuing fund the following activities were conducted: Multi-Sectoral Forest Protection Committee (MFPC) meeting; capacity building; and mobilization of Wildlife Enforcement Officers. Their activities on downloaded funds include: monitoring of 25+5 m beach easement; and monitoring of 30-m road easement; monitoring of forestland/wetland.

Other activities were quarterly monitoring of DENR pontoon; maintenance of watercraft/seacraft; maintenance of turned-over wetlands; conduct of wetland clean-up every Friday dubbed as "Wetland Fridate"; bat watching, spelunking, underwater/coastal clean up, reef assessment and seagrass assessment; and river clean-up in Nabaoy River with MFPC member.

Mines and Geosciences Bureau Activities

For CY 2023, 76 personnel collectively carried out the various mining-related activities. Of the total workforce, 41 regular personnel, nine (9) CTI, and 26 CoS. The total allotment was Php 65,085,329.07 to fund the different activities of the region.

001: Natural Resources Sustainable Managed

Issuance of mining contacts/permits and other related permits

One (1) Industrial Sand and Gravel Permit (Krushrock Corporation) and three (3) Mineral Processing Permits were issued (Blue Chip Builders, Inc., Roprim Construction, and MRCT Sand and Gravel). Thirty (30) Ore Transport Permit/Certifications were issued to firms and individuals. One thirty eight (138) Certificate of Accreditation and there (3) Certificate of Exemption were issued under Other mining-related permits [Accreditation/Certificate of Environmental Compliance and Community Relations Record (CEMCRR)].

Use it or Lose It Policy

Under this activity, eight (8) mining applications were approved with final action and reviewed 45 permits.

Safety, Health Environment and Social Development (SHES) Programs

Eight (8) Environmental Protection and Enhancement Program (EPEP) with Final Action were endorsed and approved; approved eight (8) annual EPEP with notice of fines; approved five (5) care and maintenance program (CMP); approved five (5) social development and management program (SDMP); approved 23 annual SDMP; and approved 30 Annual Safety and Health Program (ASHP) for the 1st semester.



Development of Small-Scale Mining - Assistance to Provincial/City Mining Regulatory Board (P/CMRB)/ LGUs/ Other Stakeholders

Six (6) provinces in Western Visayas were inventoried under Inventory of Peoples Small-Scale Mining (PSSM)/MinahangBayan(MB) Areas, and Quarry/Sand and Gravel (SAG)/Small-Scale Mining (SSM) Sites and 54 meetings were conducted.

Mining Industry Development Program

Forty-five (45) permits were monitored for their compliance with their work programs as part of Monitoring/Audit of Mining Permits/Contracts/Leases/Claims/JOAs (including those within Mineral Reservations) as to compliance with the Terms and Conditions/Requirements and implementation of approved Tenement and Safety, Health, Environmental and Social Development Programs (TSHES), while 44 permits were monitored on their compliance with SHES programs.

Resolution Complaints/Cases/Conflicts

Eight (8) complaints were investigated on the following: alleged illegal quarrying in PurokBaybay, Brgy. Bacjao, Buenavista, Guimaras; alleged illegal trading of sand and gravel in Buenavista, Guimaras; Iloilo illegal quarry operations in the Cabatuan, Iloilo; alleged illegal activity of black sand extraction in SitioLooc, Brgy. Old Sagay, Sagay City, Negros Occidental; alleged illegal quarry operations in Bugason Antique; alleged illegal quarrying activities in Brgy. Minanga, Dueñas, Iloilo; alleged excavation conducted in the household of Ms. Juvy Joy Ong in Brgy. Lincud, Dingle, Iloilo; and alleged illegal extraction of sand and gravel in Brgy. Toyungan, Calinog, Iloilo.

In pursuit of anti-illegal mining, two (2) Cease and Desist Orders (CDOs) were issued for violation against the terms and conditions of the Certificate of Accreditation—misdeclared entries in the delivery receipts in Brgy. Libot, Calinog, Iloilo and provisions of ECC Brgy. Pasil, EB Magalona, Negros Occidental. Two (2) Release Orders were issued for the release of two (2) dump trucks. One (1) case was filed for violation of Section 103, RA 7942— Theft of Minerals.

Communication Plan for Mineral Development

T0 bring awareness on mining related concerns, one (1) stakeholders forum was conducted, seven (7) radio/TV guestings; 24 articles released to media; and 25 articles posted on the website and social media.

Twelve (12) maps along with their 12 corresponding databases were submitted—Tenement Map; Map Info/ArcGIS Database; Tenement Map; and Map Info/ArcGIS Database.

One (1) Learning Event on Best Practices on the Establishment of Communal Bamboo Plantations by Mining Permit Holders was conducted to LGUs-Aklan, Antique, Iloilo, and

Barbara, Leganes, and Zarraga, and Buenavista, Guimaras for Iloilo City Quadrangle (3552-III); and Dumangas, Iloilo and Buenavista, Guimaras for Dumangas Quadrangle (3552-III).

These municipalities were Leganes, Iloilo, Zarraga, Iloilo, Pulupandan, Negros Occidental, Barotac Nuevo, Iloilo, Dumangas, Iloilo, Barotac Viejo, Iloilo Concepcion, Iloilo, and Banate, Iloilo.

Miscellaneous Geologic Services

Technical assistance is available to the public through the issuance of geohazard certifications for government projects such as schools, health centers, roads, and the like. Geohazard surveys and sanitary landfill site assessments are likewise provided to requesting parties.

Gender and Development (GAD)

The annual allotment of Gender and Development for CY 2023 was Php 85,136,000.00 used to fund the various activities. Highlighting the program was the conduct of National
